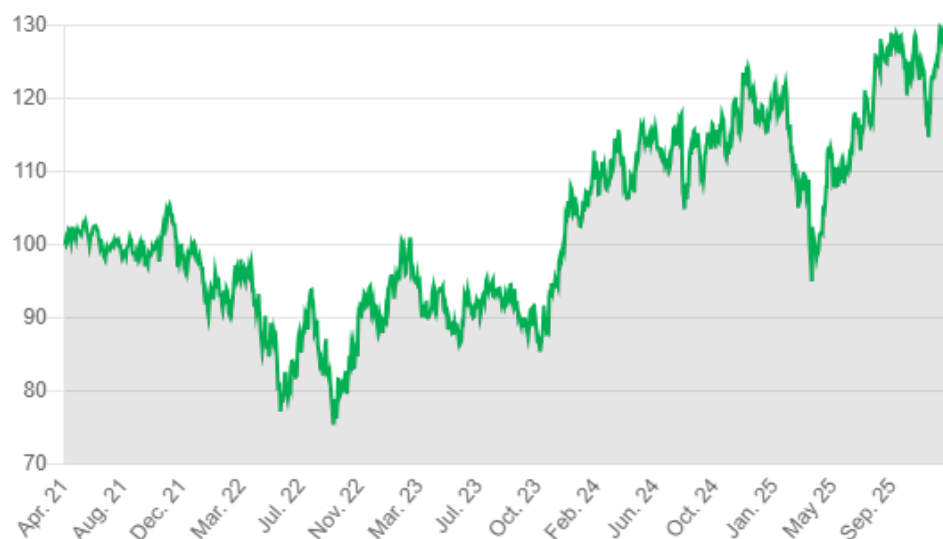


Investment goals

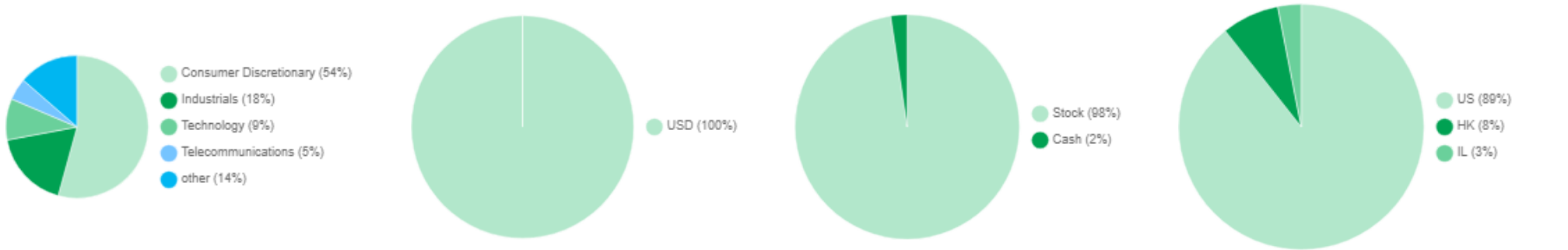
